## **Derek's Masselink Opening Statement** Nov. 1<sup>st</sup> 2008 Pender Post All Candidates Meeting

Good afternoon. My thanks to the Pender Post for hosting this event.

My name is Derek Masselink. I live, farm and work with my wife Michelle, our two daughters, Everest and Quinn and my parents Jake and Joyce Masselink in Hope Bay. My and Mom and Dad have owned the former Welcome Bay Inn in Hope Bay for over 20 years.
